

## PUBLIC NOTICE LOWER MILFORD TOWNSHIP

"AN ORDINANCE OF THE TOWNSHIP OF LOWER MILFORD AMENDING THE ZONING ORDINANCE BY REPEALING AND REPLACING ORDINANCE NO. 134 WITH AMENDMENTS THAT CLARIFY THE DELETION OF THE TERM NON-NUISANCE INDUSTRY, CLARIFY THE INTENT OF THE OVERLAY DISTRICT, **EXPANDED DEVELOPMENT AMEND** APPLICABILITY OF NATURAL RESOURCE PROTECTION STANDARDS TO LOT LINE ADJUSTMENTS THAT DO NOT PROPOSE ANY DEVELOPMENT, CORRECT USE A.9 COMMON DOMESTIC FARM ANIMALS AS PETS, AND REVISE CERTAIN REQUIREMENTS FOR THE MEDICAL MARIJUANA GROWER/PROCESSOR USE AND THE MEDICAL MARIJUANA DISPENSARY USE; BY AMENDING THE TOWNSHIP ZONING MAP TO APPLY THE EXPANDED DEVELOPMENT OVERLAY DISTRICT OVER CERTAIN TRACTS OF GROUND LOCATED ON PROPERTY IN THE TOWNSHIP IN ADDITION TO THEIR EXISTING ZONING CLASSIFICATIONS; AND BY AMENDING CERTAIN OTHER PROVISIONS TO REQUIRE SUBMISSION OF AN EROSION AND SEDIMENTATION CONTROL PLAN TO THE TOWNSHIP FOR TIMBER HARVESTING OPERATIONS, TO REMOVE THE REQUIREMENT FOR A LETTER OF ADEQUACY FROM THE LEHIGH COUNTY CONSERVATION DISTRICT FOR TIMBER HARVESTING OPERATIONS, AND TO ALLOW FOR WINERIES ON PARCELS UNDER 5 ACRES THAT DEMONSTRATE YEARLY GROSS INCOME OF AT LEAST \$10,000."
