Action on Subdivisions and Land Development – Gehman Subdivision Final Plan

Discussion took place on the newly revised Job Descriptions. Fucci explained the changes that were made, which did not affect the job duties and responsibilities, but created a more detailed and cohesive skills and qualifications. All current employees would meet new requirements.

Motion by Koplin to accept Job descriptions as presented. Seconded by Wright. 2 Ayes. 1 Nay.

Under New Business:

Motion by Quigley to not continue the waiving of the late fees for the Limeport Wastewater Treatment Plant. Seconded by Koplin. 3 Ayes.

Wright announced receipt of John Bannon's Letter of interest to Planning Commission. Fucci advised the Planning Commission who invited him to August Planning Commission meeting and appointment will be on the Board of Supervisors agenda in August.

Motion by Koplin to Approve the request made by Allentown Police Department for Lower Milford Fire Police assistance for upcoming events, Seconded by Quigley for purposes of discussion. Quigley asked representative Ed Miller about the Fire Company's level of comfort being in Allentown. 3 Ayes. w/Quigley's approval pending the Fire Chiefs decision.

During Public Comments Quigley began making statements regarding litigation. Cappuccio advised that Litigation is not to be discussed in a Public forum, at which point Quigley left the meeting at 7:20 PM and did not return.

Motion by Wright to Adjourn the Meeting. Seconded by Koplin. 2 Ayes.
