## **Under New Business:**

Discussion held on the Township's allocation of American Rescue Plan Acts Funds. Motion by Koplin, based on the recommendation of PSATS and the Township Treasurer, to create an account with PLGIT to deposit the American Rescue Plan Acts Funds. Seconded by Wright. 2 Ayes.

Motion by Koplin to formally approve the purchase of the 2021 GMC 2500HD Sierra utility cab with 8 ft Reading SL Body and Tommygate lift. Seconded by Wright. 2 Ayes.

Wright announced the Township's vacant position on the Joint Building Board of Appeals. Candidates should have a background in architecture or engineering.

Motion by Koplin to Accept the Resignation of Alicia Johnson from Planning Commission. Seconded by Wright. 2 Ayes.

Wright acknowledged the receipt of a letter of interest for the vacant seat on Planning Commission from John Bannon. No appointment will be made until the vacancy has been officially advertised.

Wright announced receipt of Docket 21-03, Appeal of Solar Energy World. No action by the Board will be taken.

Discussion took place on the condition of the Township Buildings failing septic system. Cowan Associates advised that a regrading plan cannot be completed without a confirmed location of the system. Motion by Koplin to proceed with having the Township septic system located and camera tested with the confirmation from Cowan Associates that the price will not exceed \$2,000.00. Seconded by Wright. 2 Ayes.

Lower Milford Township Board of Supervisors June 17, 2021, Meeting Minutes Wright announced receipt of the June 11, 2021, letter from Scott Beiber at Lehigh Soils and Wetlands regarding the Gehman Subdivision Sewage Planning Module. Beiber requested the Board deem the module as applicable, as DEP has not made action on the module within thirty days. Cappuccio provided background on Title 25. Motion by Koplin to accept Title 25, Section

71.55.d, and deem the Gehman Subdivision Sewage Planning Module as applicable. Seconded by Wright. 2 Ayes.

Cappuccio provided an update on 6341 Hoffman Lane building code violations. Motion by Koplin that if no building permit application has been received by June 30, 2021, approve Solicitor to move forward with legal action and seek reimbursement for legal fees. Seconded by Wright. 2 Ayes.

Tim Cougle, resident on Dekrane Drive, made comments regarding the nuisances emanating from 6341 Hoffman Lane.

Discussion held on road study options for Chestnut Hill Church Road. Motion by Koplin to request Cowan Associates to perform core borings on Chestnut Hill Church Road and test for weight study prior to oil and chip being started, with the price not to exceed \$ 2,000.00, notifying the Board of Supervisors if price exceeds limit. Seconded by Wright. 2 Ayes.

Wright announced receipt of Berkheimer's Covid – 19 EIT 4<sup>th</sup> Quarter Projects.

Public Comments were made by Jean Schock regarding the status of work being done on Scout Road.

Also, Schock commented on grass clippings being on Elementary Road from mowing. Lowell Linde clarified that the mowing was not done by the Township, but a private resident.

Jason Flexer asked about the bridge closure on Palm Rd. Wright advised Flexer to contact local State representatives.
